

## The Fabulous Find

The Fabulous Find , a 501c3 non-profit organization (listed under A Caring Community), is a boutique style resale shop at 139 State Rd (Route One) in Kittery which partners with various worthy, local non-profit organizations each month. Since their inception in mid-July of 2010, this organization has distributed just over \$1,500,000 to more than 150 local non-profits. This community resale shop with very low overhead chooses three organizations each month and whatever profits made that month are distributed to those that are chosen by their board. We were privileged to be selected for the second time in the past 3 years and on September 7th we were honored with a check of \$8,268.62 for the MWPF. **Amazing!**

## **Marginal Way Town Committee Report**

A major effort has been underway over the past year to repair the 37 separate areas on the Marginal Way damaged by the three March 2018 nor'easters.

The repair process required the preparation of budgets, reporting to the Select Board on repair activities, identification and description of each damaged area, permit application for each damaged area to the Maine DEP, selection of a Lead Contractor who will prepare necessary bid packages and oversee each repair and the selection of the contractors who will repair each damaged area.

Repairs have been completed on 10 areas with 18 in the midst of the DEP permit approval. Repairs on these areas will commence later in 2020. Coordination with FEMA has been made to prepare the necessary documentation for reimbursement of repair costs. Joan Griswold, a volunteer and Chair of the Marginal Way Committee has performed these tasks with distinction and we are extremely thankful for her efforts.

On behalf of Joan Griswold and the Marginal Way's Town Committee we want to thank and congratulate the many volunteers who showed up on Saturday, Aug.17th for the 8th Annual Pod Picking Day on Ogunquit's Marginal Way. In just three hours this impressive group picked 720 pounds of Black Swallow Wort seed pods.

Their enthusiasm and hard work have a major impact in slowing the spread of this highly invasive vine.

Thanks to Jim Oliver, of Bessie's Restaurant, in Ogunquit, volunteers were provided a delicious lunch. We are also grateful to Scott Eldredge, of Eldredge Lumber in York, for donating the largest and toughest trash bags that were filled to the brim with Black Swallow Wort. Ogunquit's Transfer Station loaded the bags and removed them for incineration. Volunteer work days like this help to spread awareness of the ongoing issues with invasive plants and the impact they have on our environment. We answered questions all morning long from visitors walking the Marginal Way about what we were doing and why. They all expressed their appreciation that so many people volunteered to battle rose thorns, poison ivy and insects to help preserve the beauty and environmental integrity of the Marginal Way.
